OLDER PERSONS AT THE CENTRE: TOWARDS A LEGALLY BINDING INSTRUMENT

Background

The 2026 United Nations International Day of Older Persons is being observed at a historic moment for the advancement of the human rights of older persons.

Pursuant to Human Rights Council resolution 58/13, the Council established an open-ended intergovernmental working group (IGWG) mandated to elaborate an international legally binding instrument for the promotion and protection of the human rights of older persons. Following its first substantive session in July 2026, the Chair-Rapporteur of the IGWG presented a report to the Human Rights Council at its sixty-third session. IGWG will reconvene later in October.

The International Day of Older Persons therefore provides a timely opportunity not only to reflect on the progress achieved, but to continue discussions on the legally binding instrument and to continue building momentum for its adoption.

The discussion will bring attention to human rights issues that need further consideration, including the situation of older persons deprived of liberty and those exposed to extreme forms of violence, abuse, and discrimination.

A crucial question will guide the discussion: **How can we ensure that older persons across different regions, backgrounds and circumstances, participate meaningfully in shaping the future legally binding instrument, in its implementation and monitoring?**
