Background

The UN Human Rights Council (HRC) in Geneva has been doing more work specifically on older people's rights in recent years. Most significantly, on 3 April 2025, UN Member States in the 58th Human Rights Council session in Geneva adopted a landmark resolution to create a new intergovernmental working group (IGWG) to draft an international legally binding instrument (UN convention) on the human rights of older persons. This milestone is the culmination of many years of

advocacy and campaigning by older persons, civil society and other advocates around the world. The evidence compiled over this period has demonstrated that the best solution to the deficiencies and fragmentation in the international human rights system is a dedicated convention.

[Click here to read the full text of resolution A/HRC/RES/58/13](#), which was proposed by a core group of Member States comprising Argentina, Brazil, the Gambia, the Philippines and Slovenia, and co-sponsored by over 80 Member States.

This IGWG will hold its first meeting over three days from 18th-20th February 2026. This will be an organisational meeting where it is expected that Member States will agree on a chair and determine the ways of working and procedures that the IGWG will adopt going forward. There are further substantive meetings scheduled to take place in July and October 2026 where the discussion will focus more on the content of the UN convention. From then onward, the IGWG will meet twice a year

GAROP and the NGO Committees on Ageing (NGO COAs) have a proven track record of convening civil society in partnership with our colleagues from National Human Rights Institutions (NHRIs), including over many years in New York at the UN Open-ended Working Group on Ageing and in recent years in Geneva. We aim to support wider civil society engagement (beyond our own membership) in an inclusive and transparent way in the interest of facilitating coordination and credibility of civil society in this space. 3. To support effective NGO and NHRI in-person participation in the session, including how we self-organise to nominate speakers if time is short
4. To nurture NGO and NHRI collaboration around the content of a UN convention

Objectives of the afternoon multi-stakeholder meeting:

1. To secure recognition from key stakeholders for civil society's self-organising structures
2. To strengthen relationships with Permanent Missions in Geneva and other stakeholders, including OHCHR and NHRIs
3. To stimulate discussion on the conceptual basis and scope of a UN convention
